## 1. TERMS AND CONDITIONS

I, the undersigned, hereby agree that the above Junior shall enroll for golf lessons with The Hazendal Golf Academy, subject to the following terms and conditions.

## 2. REGISTRATION, FEES AND PENALTIES

- 2.1 A year annual non-refundable **membership fee** of R220 shall be payable upon enrolment for trainee junior members.
- 2.2 Fees in respect of golf lessons will be determined per month as agreed, and shall be payable monthly. Group lessons will be payable in advance and individual at month end.
- 2.3 **Individual golf fees with the Head Coach** are based on taking 4 x 30min lessons per month at the current rate of R300 per lesson. If less than 4 sessions are taken, then the full rate of R350 per session applies.
- 2.4 Refer to attached rates for Individual golf fees with Assistant Coaches. The same applies as per point 2.3 above. If fewer than 4 lessons of 30 minutes are taken the full rates of R250 per lesson will apply.
- 2.5 **Group golf lesson fees** \_\_\_\_\_ see attached rates. Group lesson fees are payable at the beginning of every month. Should a Junior be unable to attend a lesson, our office should be notified beforehand. Where possible the manager of the Academy will endeavor to accommodate by making up a lesson for the junior in another slot. This is not a guarantee.
- 2.6 In the event of inclement weather, and we are unable to coach, a text message to cancel the lesson will be sent by the Academy. Where possible, a make-up lesson will be arranged. If we cannot make up the missed lesson your account will be credited.
- 2.7 In the event that any fees are not paid within 14 days of the commencement of the month, a 10% late penalty shall automatically be charged.
- 2.8 Fees are subject to change at the beginning of each calendar year.
- 2.9 All fees include the cost of balls and other equipment needed such as clubs and training aids if required by the junior, for the duration of the lesson.

All costs will be directly sent to you each month for payment to Hazendal Golf Academy.

## 3. DRESS CODE CLUB / RANGE RULES

- 3.1 All Juniors are to wear closed shoes/takkies when attending lessons or playing at the club/range. Collared shirts to be worn.

## 4. MISSED LESSONS AND LATE ARRIVALS

- 4.1 It is recorded that The Hazendal Golf Academy (THGA) operates on a strict schedule and substitute lessons, specifically group lessons, therefore tend to be difficult to accommodate. If you require flexibility, it is recommended that you select individual lessons.
- 4.2 Individual lessons....see rates attached. While THGA appreciates that it is unfortunate that children fall ill or have unforeseen commitments that may interfere with lessons, our golf coaches commit to be at the range and their remuneration remains payable. Therefore, 24 hours notice is required. If we do not receive the cancellation within the required notice period, the lesson shall be forfeited. We will however be reasonable in such circumstances.
- 4.3 Late arrivals will result in receiving only the remaining time of the lesson. The Junior is required to arrive 5 to 10 minutes prior to commencement of the golf lesson to warm up.

## 5. TERMINATION AND/OR POSTPONEMENT OF LESSONS

- 5.1 The parent/legal guardian shall give one full calendar month's written notice withdrawing the Junior from THGA or postponing lessons, failing which fees in lieu of notice shall be payable.  
The Hazendal Golf Club and the Academy reserves the right of admission and reserves the right to terminate its services at any time during the period of this agreement at the sole discretion of the Director or Golf Manager.

## 6. DEFAULT

- 6.1 Should the parent/legal guardian fail to pay any fees, penalties or any other monies punctually on due date or

should the parent/legal guardian commit or permit any breach of the conditions of this agreement, THGA shall have the right to give Seven (7) calendar days' notice in writing to the parent/legal guardian, to terminate this agreement. Such termination shall not affect the right hereby reserved to THGA to recover all monies that may be due to it by the parent/legal guardian calculated to the date of such termination, and for any damage arising by reason of such breach of the parent/legal guardian, including any loss THGA may sustain by reason of the premature termination of this agreement.

6.2 Should THGA institute action against the parent/legal guardian pursuant to a breach of this agreement then without prejudice to any other rights which THGA may have, THGA shall be entitled to recover from the parent/legal guardian all legal costs incurred by it, including attorney/client costs and collection charges.

**7. UNDERTAKING AND INDEMNITY**

7.1 By signing this enrolment form, I understand that I am entering into a legally binding contract to pay all fees due and payable to Hazendal Golf from time to time and I agree to be bound by the terms and conditions contained herein.

7.2 I hereby undertake and agree to comply with all the rules and regulations of the Hazendal Golf Academy and I acknowledge that failure to comply with the rules and regulations will result in the termination of this agreement without notice. I understand that THGA reserves the right to make any changes to its rules and regulations with or without notice if deemed necessary.

7.3 I am aware that golfing involves many risks, dangers and hazards including, but not limited to, slips and falls, being hit by stray golf balls or golf clubs, accidents or collisions involving motorized golf carts, lightning strikes, micro shocks and radiation from the power lines, encounters with domestic or wild animals, failure to act safely or within one's own ability or to stay within designated areas, or negligence of other persons. I fully understand and accept that all golf lessons will be undertaken at my own risk and at the risk of the golfer. Acting on behalf of myself and the Junior, I hereby waive any claims which I, the Junior golfer, his/her heirs and/or successors may have against THGA for any and all injuries, losses and damages to the Junior, the Junior's personal property and my personal property.

On behalf of myself, the executors of my estate, my spouse, the aforesaid Junior, I hereby indemnify, hold harmless and absolve Hazendal Golf Academy (Hazendal Wine Estate Pty Ltd), its directors, management, coaches and any other such staff against and from any claims whatsoever that may arise in connection with any loss and damage to the property, or injury, illness or death of the Junior in the course of any activity. Notwithstanding, THGA, its directors, management, coaches and staff will take reasonable precautions for the safety of welfare of the Junior.
